Abstract

The Student Work Lecture (KKM) in 2021 held by Bina Bangsa University is different from previous years. This year it was carried out during the Covid-19 Pandemic directly to the field in groups, not online. With the KKM during the Covid-19 pandemic, this is hope that the students will still have the values of service to develop student competencies and social interactions in the community. This study aims to determine the role of Student Work Lectures as a form of community service. The population and sample in this study were 52 KKM Bina Bangsa University with a total of 20 people from 1314 people in 2021. Data collection methods. They are using interviews, observation and documentation. The interview method in this study is to get information to the public about the beneficial values of KKM activities during the Covid-19 Pandemic in Mekarsari village, Carenang sub-district. The results in this study indicate that the community can still feel KKM activities as a form of community service during the Covid-19 pandemic. The role of students can still be carried out with a series of innovative activities and continue to carry out health protocols.

INTRODUCTION

The Law on Higher Education (Indonesia, 2012) states that community service is an activity of the academic community in practising and civilizing science and technology to promote public welfare and educate the nation. The community service program carried out by universities (PT) is one of the implementations of the Tridharma of Higher Education. This program is carried out in various forms, for example, community education and training, community services, and action studies of Science and Technology (Science and Technology) produced by universities. This program aims to apply science and technology to community empowerment to produce changes in the knowledge, skills, and attitudes of the target community (Noor, 2010).

Student Work Lecture (KKM) is a form of community service activity by students with a cross-scientific and sectoral approach at certain times and areas. KKM is a lecture activity and fieldwork that integrates education and teaching and community service by students in a systematic, broad-dimensional way through a multidisciplinary, comprehensive and cross-sectoral approach. KKM is a compulsory subject in all undergraduate study programs at Bina Bangsa University (UNIBA). The core of this KKM course is learning as well as community service. Therefore, all activities that contain learning values and community service can recognize as KKM. These activities are during the KKM period in the current semester (Wulansari Sisca et al., 2020).

The Student Work Lecture (KKM) activity at Bina Bangsa University in 2021 took the theme "Community Service in Revitalizing the Impact of the Covid-19 Pandemic: Contribution of the Bina

Bangsa University (UNIBA) for the 2020/2021 Academic Year. Student Work Lecture (KKM) is a field activity carried out by students for a specific time and implements the Tri Dharma of Higher Education. This KKM expects to analyze problems and focus on assistance to prepare superior human resources based on the Creative Economy and other fields. All KKM activities aligned with the village government's strategic development programs and plans, especially in Mekarsari village, Carenang district, and Serang district. The implementation of the KKM in 2021 is different from the previous year because, at the moment, it coincides with the Covid-19 Pandemic. Covid-19 entered Indonesia in March 2020. It caused all activities to be different and limited, including student service activities, namely Student Work Lectures (KKM).

The KKM in 2021 can carry out in several ways, including the Thematic KKM, which is carried out in groups and then distributed to several sub-districts in the province of Banten. KKM is a form of implementation of the Tri Dharma of Higher Education, namely community service. However, KKM can also be an opportunity to implement the Tri Dharma of Higher Education in other forms, namely teaching and research. Students are required to have creativity and innovative behaviour to fulfil these three things. In this study, the author wants to realize a more optimal implementation by implementing KKM as a community service.

This KKM activity emphasizes the role of KKM as a form of community service during the Covid-19 pandemic. So it is hoped that this can be a novelty or novelty and comparison for further research.

According to Veitzal Rivai, "role is behavior that is expected and regulated by someone in a certain position". (in the Journal of PKM E-Amal, Vol. 1 No. 1, January 2021). According to Ali, "A role is an event that is under the influence of being part of a leader." According to Soerjono, a role is a dynamic aspect of status or position. If a person performs an obligation and only follows his position, then that person has performed a role. The difference between position and role is of scientific interest. The two can not separate. No role without a position and no role without a role. According to Soerjono, the role includes three things:

- 1.Roles include norms related to a person's position or existence in society. There are four norms, namely:
- 2.usage
- 3.folkways
- 4.mores
- 5.customs
- 6.A role is a concept that includes what individuals can do for society as an organization.
- 7. Roles can interpret as behaviours that are important to the social structure of society.

In addition, the role can also interpret as the expectation of an individual who has a certain social status in the population. The expectations that arise are the impact of the prevailing social norms, so it can say that the role is determined by the norms that apply in society. From the brief description above, it can conclude that the role is a series of everyday actions that arise from a specific position and situation.

According to the guidebook for Student Work Lectures (KKM) in 2021, Bina Bangsa University defines Student Work Lectures (KKM) as field activities carried out by students for a certain period and are part of the implementation of the Tri Dharma of Higher Education. KKM are expected to be able to analyze problems and focus on assistance to prepare superior human resources based on the Creative Economy and other fields, into eight excellent program areas, including:
